#### MEMORANDUM FOR AFLCMC/HNCX - PLATFORM ONE

FROM: Air Force Rapid Cyber Acquisition (RCA) Authorizing Official (AO)

SUBJECT: Authorization To Operate With Conditions (ATO-C): Iron Bank Authorization Termination Date (ATD): 12 August 2023; Authorization To Operate With Conditions (ATO-C): Party Bus Authorization Termination Date (ATD): 12 August 2023; continuous Authorization To Operate (cATO): Platform One (CI/CD pipeline)

- 1. I have determined that the subject effort has a residual risk level of **MODERATE**. Conditions for this authorization are provided at **Attachment 1**.
- 2. **Iron Bank** is IL2 Development & IL5 Production cloud environment and has external connections to Cloud One (IaaS), Vendor Services and Satellite Servers at IL2. **Party Bus** is an IL2/4/5 Development, Staging & Production cloud environment and IL2/4/5 pipeline, conforming to the DoD Reference Architecture and Continuous Authorization Guide (cATO).
- 3. **Big Bang**, a Platform One product, has a Body of Evidence (BoE), (SCTM & control mapping on products). The **Big Bang** BoE is provided as applicable and defined by the Designated Department of the Air Force (DAF) AO.
- 3. My determination is based on the assessment of the security posture, identified risks, system specific requirements, proposed and agreed to mitigations, and all supporting documentation evaluated in accordance with DOD guidance. Key documents from the Body of Evidence reviewed are identified in **Attachment 2.**
- 4. This authorization is my formal declaration that appropriate system security measures and/or countermeasures for the identified risks have been properly implemented and that a satisfactory level of security is present for operations. This authorization is for the version as documented in artifacts provided. Any changes or upgrades to the system baseline will need to be assessed. A Plan of Action and Milestones (POA&M) is required to be maintained, reviewed, and progress reported.

	from date of 5 April 2021.
4	Auditing requirements will be provided to Iron Bank No Later Than (NLT) 30 days of this
	ATO.
5	Provide runtime monitoring tool for Iron Bank container pipeline.
6	All POA&M(s) items must be worked prior to the expiration of this ATO, within the
	prescribed timelines.
7	Iron Bank will have an IL5 pipeline (Staging/Production) to include a full engagement with
	Team Rocket (TR) NLT 31 January 2022

7	Ensure all containers deployed within the <b>Platform One pipeline</b> are compliant with the
	Platform One DevSecOps (DSOP) CONOPs, NLT 270 working days from the date of this
	ATO.
8	All Party Bus Staging & Production environment(s) will be STIG compliant NLT 17
	December 2021.
9	All POA&M(s) items must be worked prior to the expiration of this ATO, within the
	prescribed timelines.
